



# LA QUINTA RESIDENT CARD INFORMATION

*Residency shall be determined as a person's primary and permanent home. Property ownership alone does not qualify an individual for a Resident Card.*

## **QUALIFYING OPTIONS FOR EACH APPLICANT:**

### **Option I:**

1. Current California Driver's License with your physical La Quinta address on it.

### **Option II:**

1. Current California Identification Card with your physical La Quinta address on it;  
**AND**
2. Current (within the last 60 days) utility bill (cable, electric, gas, or water).

### **Option III:**

1. Property Tax Bill (Riverside County Tax Assessor Record) from the current Fiscal Year;  
**AND**
2. Current (within the last 60 days) utility bill (cable, electric, gas, or water);  
**AND**
3. Photo identification matching the name on both the property tax and utility bill.

## **Resident Cards will not be issued to customers with fractionalized or multiple ownership.**

Dependents (up to age 23) may obtain Resident Cards by providing legal documentation proving that person is a resident's dependent.

*Cards may be purchased at the Wellness Center, 78450 La Fonda, La Quinta, CA on Mondays, Wednesdays, and Fridays from 10:00 am to 3:00 pm (closed 12:00 pm-12:30 pm) and the First Saturday of each month (November-April only) from 8:00 am to 12:00 pm.*

## **RULES GOVERNING USE OF LA QUINTA RESIDENT CARD**

1. Resident Cards may be used only by the registered cardholder.
2. Cardholders may book tee times up to 3 days in advance. Cardholders reserving a tee time more than 3 days in advance will be charged the full posted rate.
3. Guests (up to 3) accompanied by a Cardholder will receive a 30% discount off the full posted rate. Discount does not apply to Twilight or any afternoon discounted tee times.
4. Resident Cards must be shown at the time of check-in. Residents who do not present their Resident Card will be charged the full posted rate.
5. Cardholders will receive a 15% discount off food at the Grill Room (not including beverages or beverage cart items).
6. Cardholders will receive a 15% discount off merchandise in the Golf Shop (not including sales items or golf equipment).
7. Cardholders are required to guarantee tee times with a credit card. No-shows will be billed the full posted rate. Cancellations are accepted but must be received 24 hours prior to the scheduled tee time.
8. Resident Cards are valid for 3 years and expire at the end of the month in which they are issued. The renewal fee is \$150. La Quinta Resident Cardholders renewing must provide all necessary information proving residency status (see qualifying options).
9. Lost or stolen cards may be replaced for a fee of \$15.
